03). The APGENCO also directs that offices under the control of APGENCO shall remain closed on all Sundays and Second Saturdays in all the months during the year 2017.

In addition to the above, General Holidays, the employees under the control of APGENCO may avail themselves of Optional Holidays not exceeding FIVE during the year 2017 on the festivals/Occasions specified in the above to these orders at their option irrespective of the religion to which the festival pertains. However, permission to avail any of these holidays should be applied for, in writing in advance and will normally be granted by the superior officer competent to grant casual leave except when the presence of an individual employee is considered necessary in the exigencies of the work of Andhra Pradesh Power Generation Corporation Limited.
