APGENCO - Pension – A.P. Revised Pension Rules, 1980 - Orders issued in G.O.Ms.No.87, Finance & Planning (F.W.-Pen. I) Department, dated 25-05-1998 for calculation of pension based on the pay last drawn-Extension of the benefit to all employees retired prior to 25-05-1998 and surviving on that date - Adoption and implementation of G.O. Ms. No. 223, Finance (HRM-VI) Department, dated 15.12.2014 - Orders - Issued.

The Government in G.O 1st cited, issued orders for treating the last pay drawn as the emoluments for calculation of Pension duly dispensing with procedure of calculating the pension based on the average emoluments drawn during the last 10 months of service with a view to liberalize the procedure for computation of Pension. Those orders were given effect from 25-05-1998. The erstwhile APSEB in the reference 2nd cited, adopted the Government orders in respect of the Board employees. The APTRANSCO in the reference 4th cited, adopted the Government orders in respect of the Board employees.

- 2) The Government, of A.P. vide reference 3rd have issued orders in pursuance of the orders of Hon'ble Andhra Pradesh Administrative Tribunal (APAT), Hon'ble High Court of Andhra Pradesh & the Hon'ble Supreme Court of India, to extend the benefit of orders issued in the G.O. 1st read above to the Government servants retired prior to 25-05-1998 and living on the date of issue of G.O. 1st read above.
- 3) Further, the Govt. of Andhra Pradesh in the reference 3rd cited have issued orders that the pension of those retired employees to whom the concession is being extending in Para-2 above shall be revised and re-fixed duly considering the pay last drawn by them as emoluments for calculation of pension under Rule 45(2)(b) of the A.P. Revised Pension Rules, 1980. Necessary amendments to the A.P. Revised Pension Rules-1980 will be issued separately.
- 4) After careful consideration, APGENCO hereby issue orders that the benefit of orders issued in the G.O.Ms.No.87, dated 25-05-1998 which were adopted vide B.P.Ms.No.90, dated 24-06-1998 shall be extended to the Board employees retired prior to 25.05.1998 and living on the date of issue of the order.
- 5) Further APGENCO hereby issues the following instructions:
 - i. All eligible Pensioners shall apply in the Armexure-I of this order to their pension sanctioning authorities duly enclosing the relevant documents.
 - ii. The pension sanctioning authority has to calculate the revised pension as per the last pay drawn and the net qualifying service as per Rule 45(2)(b) and take further action for settlement of pension as per rules.

- iii. Service pensioners who retired prior to 25.05.1998 and whose pension is fixed based on average emoluments are only eligible for payment of arrears w.e.f. 25.05.1998.
- iv. Service pensioners who retired prior to 25.05.1998 and expired on or before that date are not eligible for payment of arrears as per the judgment.
- v. In respect of Surviving Pensioners as on 25.05.1998 and died after 25.05.1998 arrears have to be paid as per rules in force to the legal heirs of the deceased pensioner.
- vi. The pensioners covered under the Judgment are not entitled to any arrears relating to gratuity and commutation of pension as per para-15 of the Judgment of Hon'ble APAT.
- vii. The subsequent revised consolidation of pension based on the revised pension shall be done without further delay.
- viii. The arrears arising out of revision of pension due to the orders issued in para 5 above shall be paid in three equal installments as detailed below:

First Installment: 1/3rd of the arrears amount in the first quarter of the financial year 2015-16

Second Installment: 1/3rd of the arrears amount in the third quarter of the financial year 2015-16

Third Installment: 1/3rd of the arrears amount in the third quarter of the financial year 2016-17
