ORDER:

Under Reg.14(a)(1) of APSEB Service Regulations Part-II, as adopted, **7(Seven) Nos.** Divisional Engineers (Elect.) are promoted to act temporarily as Superintending Engineers (Elect.) with effect from the date of assumption of charge.

2. The promotion ordered in para-1 above is purely temporary and is liable to be terminated at any time without notice and without assigning any reasons thereto.
3. The promotion ordered in para-1 above is liable to be reviewed based on the outcome of ;
 - a) The Judgment to be delivered by the Hon'ble Supreme Court in the appeal filed against the judgment in W.P.No.4219/78 and W.P.Nos.2360-91/1983.
 - b) The Judgment to be delivered in W.P.Nos.15565/1989, 3482/1990, 5135/1990, 9558/1991 and W.A.No.135/1996 pending before the Hon'ble High Court of A.P.
 - c) The Judgment to be delivered in W.P.No.3470/2008 pending before the Hon'ble High Court of A.P. and
 - d) Result of final allocation of State Cadre employees between APGENCO and TSGENCO, that may occur as per the A.P.Reorganisation Act.,2014, besides subject to the outcome of batch of writ petitions, No.16849/2015 and others pending before the Hon'ble High Court of Judicature at Hyderabad.
4. The **7 (Seven) Nos.** Divisional Engineers (Elect.) on temporary promotion as Superintending Engineers (Elect.) and 4 Nos. existing Superintending Engineers (Elect.) are transferred and posted to the places noted against each in the Annexure appended to this order.
6. The concerned controlling officers are requested to relieve the above Superintending Engineers / Divisional Engineers (Elect.) by making local arrangements so as to enable them to join at the place of posting ordered above.

7. They are requested to assume charge on promotion as Superintending Engineer (Elect.) at the place of posting within 10 days from the date of relief. If they fails to join or evade joining within stipulated period or proceed on leave from the date of receipt of this order, their promotion rights shall be forfeited for the current panel year and the name of the candidate shall be placed before the next DPC for consideration in the next panel year subject to availability of vacancy in terms of G.O.O. cited. Necessary departmental disciplinary action as deemed fit shall also be initiated against them for non-compliance of orders. No request for change of posting or sanction of leave will be entertained.
