ORDER :-

In the G.O.O. 3rd & 4th read above, orders have been issued enhancing the Uniform Allowance to Rs.3,000/- from of Rs.2,000/- each per annum and sanction of Uniform Maintenance Allowance Rs.150/- instead of Rs.100/- per month with effect from 15.12.2015 for the security staff (i.e., SSI and above cadres) & Fire Service staff consequent to the orders issued vide G.O. 2nd read above.

02). The Chief of Vigilance & Security in the U.O cited has requested to extend the orders issued in the G.O.O. 3rd & 4th cited in respect of Security Guards working in APGENCO.

After careful consideration, it is hereby ordered that the Security Guards shall be paid Uniform Allowance Rs.3,000/- instead of Rs.2,000/- each per annum and Uniform Maintenance Allowance Rs.150/- instead of Rs.100/- per month with effect from 15.12.2015 on par with the Security & Fire Staff.
