**ORDER:**

04) The promotion ordered above is subject to the result/review of final allocation of State cadre employees between APGENCO & TSGENCO, that may occur as per the AP Re-organization Act, 2014, besides subject to the outcome of Batch of Writ Petition No.16849 and others, pending before the Hon'ble High Court.

05) Sri A.S.Balaji, Senior Accounts Officer/R&A/VS/Hyd. on promotion as Deputy CCA ordered above, is transferred and posted as Deputy CCA/Dr.NTTPS vice Sri P.Someswara Rao, Dy.CCA who is retiring from service on superannuation on 30.06.2017 vide reference 4<sup>th</sup> cited.

06) The concerned controlling officer is requested to relieve Sri A.S.Balaji, Senior Accounts Officer by making local arrangements so as to enable him to relieve the retiree positively on 30.06.2017 A.N.

Necessary departmental disciplinary action as deemed fit shall also be initiated against him for non-compliance of orders issued above.
