ORDER :

In terms of the orders issued vide G.O.1<sup>st</sup> cited, an amendment to the Regulation.16(a)(1) of APSEB Service Regulations Part-I, as adopted by APGENCO, has been issued enhancing the age of superannuation from 58 years to 60 years “with immediate effect” vide G.O.O.4<sup>rd</sup> cited. Further, an addendum to the said Regulation.16(a)(1) of APSEB Service Regulations Part-I has been issued vide G.O.O. 9<sup>th</sup> cited, substituting the words “with effect from 02.06.14” in place of “with immediate effect” in terms of the orders issued vide G.O.O. 8<sup>th</sup> cited read with G.O. 5<sup>th</sup> cited.

2. Further in the memo 10<sup>th</sup> cited, instructions have been issued to effect re-induction of retired employees; wherein it is stipulated under para-5(a) that, he/she eligible for re-induction into service shall remit the pensionary benefits released to them viz. (a) Commuted value of pension ( b) Retirement Gratuity (c) Encashment of Earned Leave along with interest @ SBI MCLR+2.5% per annum till date of remittance.

3. Accordingly, in memo 11<sup>th</sup> cited, Sri P Kumara Babu, CE (Retired on 30.04.17 A.N.) was issued notice to remit the pensionary benefits released to him along with interest thereon on or before 30.09.2017. In response to the notice, he has deposited an amount of Rs.77,65,525/- (Rupees Seventy seven lakhs sixty five thousand five hundred and twenty five only) on 05.09.2017 and requested for issue of re-induction orders vide references 12<sup>th</sup> cited.

4. After careful consideration, Sri P Kumara Babu, (Retired on 30.04.17 A.N.) is hereby re-inducted into service of APGENCO with effect from 05.09.2017 and posted as CE/O&M/Srisailarm/SRBPH, subject to the conditions mentioned vide memo 10<sup>th</sup> cited.

5. He is requested to assume charge accordingly within 7 days from the date of issue of these orders.
