ORDER :-

In the reference 1st read above, APGENCO issued orders enhancing the ceiling of House Building Advance to the employees of APGENCO duly revising the pay ranges as per revision of pay scales 2010.

02). In the G.O 4th cited, the Government of Andhra Pradesh have issued orders enhancing the existing ceiling amount for sanction of House Building Advance to the State Government employees.

03). After careful consideration and in modification of the orders issued in the reference 1st read above, the APGENCO hereby enhances existing ceiling of House Building Advance to the employees of APGENCO duly revising the pay ranges as per the Revision of Pay Scales, 2014, vide references 2nd & 3rd read above as detailed below :-

b).	Employees drawing basic pay above Rs.31,625/- and upto Rs.50,100/- pcr month.	Rs.12.30 Lakhs	-do-	-do-
c).	Employees drawing basic pay above Rs.50,100/- and upto Rs.73,515/- per month	Rs.15.00 Lakhs	-do-	-do-
d).	Employees drawing basic pay above Rs.73,515/- per month	Rs.20.00 Lakhs	-do-	-do-
e).	All India Service Officers working in the State (All India Service Officers working in the State may be given the option to choose either the State Government ceiling or to adopt Government of India rules)	Rs.25.00 Lakhs	Or 50 times of basic pay whichever is less	-do-

04). Further, APGENCO hereby enhance the existing ceiling of House Building Advance for repairs/extension etc., to twenty times of basic pay in the Revised Pay Scales, 2014 or Rs.4.00 Lakhs whichever is less. The Advance can also be sanctioned to those employees who have availed HBA.

05). Sanction shall be accorded for purchase of house site at ten times of basic pay in the Revised Pay Scales, 2014 or Rs.2.00 Lakhs whichever is less.

06). APGENCO further ordered that the following existing recovery patten shall continue which is as under :-

House Building Advance	: 300 monthly instalments i.e., 240 principle + 60 interest
Repairs	: 90 monthly instalments i.e., 75 principle + 15 interest
House site	: 72 monthly instalments i.e., 60 Principle + 12 interest.

07). Penal interest shall be charged at double the rate of normal interest in case the advance are mis-utilized or not utilized at all and 1 ½ times the normal rate for non-compliance with formalities.

08). All other conditions governing the sanction of House Building Advance under the existing rules shall continue.
