ORDER:

Sri N Haridas (H.T.No.13090936) selected candidate in 1:3 select list filed W.P.No.29415/2011, praying the Hon'ble Court to stay appointment orders of viz.(i)Sri Tejavath Kumar (H.T.No.13140118), (ii)Sri Bhukya Ramesh, (H.T.No.13140034), (iii) Sri M Ramaiah (H.T.No.13120647) & (iv)Sri Komaram Chitti Babu (H.T.No.13100771). The Hon'ble High Court of A.P. in the reference 2nd cited has ordered "there shall be interim stay as prayed for". Accordingly, in letter dated:17.11.2011, appointment orders of all the above 4 selected candidates were kept in abeyance till the final outcome of the Writ Petition.

2. Aggrieved by the above, the petitioners Sri Tejavath Kumar (H.T.No. 13140118), Sri M Ramaiah (H.T.No. 13120647) & Sri Komaram Chitti Babu (H.T.No.13100771) & Sri Bhukya Ramesh, (H.T.No.13140034) have filed vacate petitions. The Hon'ble High court in the reference 4th cited has vacated interim stay ordered on 08.11.2011 in respect of Respondent No.3 & 5 i.e. Sri Tejavath Kumar (H.T.No. 13140118) & Sri M Ramaiah (H.T.No. 13120647). Accordingly in the reference 5th cited the two candidates were issued appointment orders.

3. Now, in respect of Respondent Nos.4 & 6 i.e. Sri Bhukya Ramesh, (H.T.No.13140034) and Sri Komaram Chitti Babu (H.T.No.13100771), in the reference 6th cited, the Hon'ble High Court has ordered that, subject to final orders in the writ petition, the interim stay to the extent of the Hon'ble High Court dated:19.04.2012 in **WVMP Nos.4390 & 4802 of 2011** in W.P.M.P.No.36424/2011 in W.P.No.29415/2011

4. In view of the above, in continuation of the orders issued in the G.O.O.s cited, and under Regulation 14(a)(1) of APSEB SRs Part-II, as adopted by APGENCO, the following two candidates are appointed temporarily by **Andhra Pradesh Power Generation Corporation Limited** as Trainee Sub-Engineer in the time scale of pay of **Rs.11545-485-13000-650-16250-800-20250-955-23115** with usual allowances admissible from time to time and they are placed on training for a period of one year.

- (i) Sri Bhukya Ramesh, (H.T.No.13140034)
- (ii) Sri Komaram Chitti Babu (H.T.No.13100771)

5. The appointment of Trainee Sub-Engineer is provisional and liable for termination at any time without notice and without assigning any reasons and these orders are also subject to the final outcome of the W.P.No.29415/2011 pending disposal by the Hon'ble High Court.

6. The conditions of service of the candidate will be governed by the rules and regulations applicable as framed or as amended by **Andhra Pradesh Power Generation Corporation Limited** from time to time. The Tripartite Agreements entered into among the erstwhile APSEB, Govt. of A.P. and Employees Associations are not applicable to the candidate and he/she shall at no stage be entitled to claim any right whatsoever arising out of the said Tripartite Agreements. The candidate has already submitted an undertaking to this effect along with the following Original Documents submitted on 12.10.2011

- i. Documentary evidence of Educational Qualifications viz., Diploma in Electrical or its equivalent, along with year-wise marks memoranda.
- ii. Documentary evidence of age viz., SSC/ICSE/CBSE or Date of Birth Certificate issued by the competent authority.
- iii. Documentary evidence of Caste (latest by 6 months/Permanent).
- iv. Certificate of Residence/ School Study Certificate.
- v. Employment Exchange Registration Card, if any.
- vi. Certificate of Physical Fitness issued by a Govt. Medical Officer of rank not lower than that of Civil Surgeon (or) District Medical Officer.
- vii. Certificate issued by the District Medical Board in respect of Physically challenged.
- viii. A bond on non-judicial stamp paper worth Rs.100/- (Rupees One hundred only) shall be executed to the effect that;
 - a) he/she will serve the CORPORATION for a minimum period of 5 years after completion of training, in case he/she is appointed on regular basis;
 - b) If the candidate leaves the CORPORATION during the period of training, he/she shall refund to the Corporation the emoluments received by him/her during Training period plus Rs.25,000/- (Rupees twenty five thousand only) by way of liquidated damages.
 - c) If the candidate leaves the Corporation, during the bond period, he/she shall pay to the Corporation an amount of Rs.50,000/- (Rupees Fifty thousand only) by way of liquidated damages.

The original certificates will be retained until agreement period is over.

7. The appointment order is subject to the following conditions; namely:
- a. The appointment is subject to verification of character and antecedents. If any adverse report is received in the said verification, his/her services are liable for termination without notice.
 - b. The original certificates deposited with APGENCO will be retained with the Corporation for a period of six years i.e 1 year Training Period plus 5 years. However, the APGENCO may consider for return of original certificates on temporary basis to the candidate after completion of three years from the date of joining on written request after depositing caution money of Rs.25,000/- (Rupees Twenty Five thousand only) with APGENCO which will be refunded on re-depositing back the original certificates to the Corporation.

c. The candidate appointed as Trainee Sub-Engineer shall work wherever he/she is posted and no request for change of posting will be entertained.

8. The candidates appointed as Trainee Sub-Engineers are posted to the places noted against their names in the Annexure appended to this order. During the training period, the candidate shall undergo modular training at the TI/Dr.NTTPS for a period of 2 (Two) months mentioned against their names in the Annexure and also on job training at the place of posting ordered during the training period.

9. They are requested to report at the place of posting ordered above duly producing Appointment order along with the acknowledgement slip issued by Assistant Secretary (V&R)(T)/VS/Hyd. If they does not report at the place of posting within a period of 30 (thirty) days from the date of receipt of this order, the offer of appointment shall automatically stands cancelled and the name of the candidate shall be omitted from the list of approved candidates and the appointment orders as Trainee Sub-Engineer will be cancelled with out any further notice.

10. The provisions of EPF & MP Act 1952 and the Employees Provident Funds Scheme 1952 are applicable to the candidate in terms of G.O.O. No.708/GM(Adm)/2002 Dtd. 6.2.2003.
