ORDER:

After careful consideration in pursuance of Sub-Section (2) of Section 185 of the Electricity Act, 2003 (Central No. 36 of 2003 and in exercise of the powers conferred by Sub-Rule-7 of Rule-7 of the A.P. Electricity Reforms (Transfer Scheme) Rules-1999, and Regulation-41 of APSEB Service Regulations Part-II as adopted; the APGENCO issues the following Amendment to the Annexure I & III referred to in Regulation-6(a) and Regulation-14 respectively of APSEB Service Regulations Part-III ordered vide GOO 3rd & 4th cited.

2. The Amendment hereby made shall come into force at once.

AMENDMENT – I

The words occurred i.e. “Appointment by Transfer” below the Direct Recruitment under Column (2) against the post of Chemist in Annexure-I of the APSEB Service Regulations Part-III shall **be deleted**.

AMENDMENT – II

In Annexure-III under the heading APSEB Engineering Service, against the category “Chemist” under Column (3), in the “Note” under item-b for the words **“not exceeding the age of 45 years as on last date of submission of application for the post of Chemist”**

- i) **the following shall be substituted, namely;**

“Irrespective of their age”

- ii) after the item(c) the following, and shall be added and numbered as (d)

“Service weightage marks of maximum ‘10’ to the in-service candidates working in Chemical related area i.e. ‘2’ weightage marks for each completed year of experience”.
