ORDER:

Under Regulation 14 (a) (1) of A.P.S.E.B. SRs Part –II, as adopted, 18 (Eighteen) Junior Accounts Officers, as annexed to this order, are promoted temporarily to act as Assistant Accounts Officers with effect from the date of assumption of charge.

- 02). The promotions ordered in para –1 above are purely temporary and liable to be terminated at any time without notice and without assigning any reasons thereto.
- 03). The promotions ordered in para –1 above are subject to result of S.L.P.Nos.2360 –91/83 filed by the Retired Officers of the erstwhile APSE Board and pending in the Honourable Supreme Court of India and W.P. No.1173/91 pending in the Honourable High Court of Andhra Pradesh.
- 04). The promotions ordered above are subject to result/review of final allocation of State cadre employees between APGENCO & TSGENCO, that may occur as per the AP Re-organization Act, 2014, besides subject to the outcome of Batch of Writ Petition Nos.16849 and others, pending before the Hon'ble High Court.
- 05). The Junior Accounts Officers on promotion as Assistant Accounts Officers ordered above are transferred and posted to the place noted against each as indicated in the Annexure appended to this order.
- 06). The concerned controlling officers are requested to relieve the above Junior Accounts Officers by making local arrangements within 15 days from the date of issue of this order. Otherwise the promotee shall be treated as deemed to have been relieved of his/her duties after expiry of the stipulated period.

07). They are requested to assume charge on promotion as Assistant Accounts Officer at the place of posting. If they fails to join or evade joining within the stipulated period or proceeded on leave from the date of receipt of this order, their promotion right shall be forfeited for the current panel and the name of the candidate shall be placed before the next DPC for consideration in the next panel year subject to availability of vacancies, in terms of orders issued in G.O.O.No:231/ JS (P)/08, Dt:02.08.2008. Necessary departmental disciplinary action as deemed fit shall also be initiated against them for non-compliance of orders issued above. No request for change of posting or sanction of leave will be entertained.
