The APGENCO hereby accords sanction for the rates of Dearness Allowance to all the Employees of APGENCO in the Revised Pay Scales, 2014 and Dearness Relief to the Pensioners/Family Pensioners with effect from 01.01.2015 as indicated below:

(i) Dearness Allowance to the Employees drawing Revised Pay Scales of 2014:-

<u>D.A. Rates from 01.07.2014</u>	<u>Revised D.A. rates from 01.01.2015</u>
3.321% of Pay	6.340% of Pay

(ii) Dearness Relief to Pensioners/Family Pensioners:-

<u>D.R. Rates from 01.07.2014</u>	<u>Revised D.R. rates from 01.01.2015</u>
3.321% of Pension/ Family pension	6.340% of Pension/ Family pension

2. The Dearness Allowance Arrears as per the increased rates for the month of January 2015 & February 2015 shall be paid in cash along with salary for the month of March 2015 payable in April 2015 to all the Employees of APGENCO.

3. The Arrears of Dearness Relief to Pensioners/Family Pensioners as per the increased rates for the month of January 2015 & February 2015 shall be paid in cash along with the Pension/ Family Pension for the month of March 2015 payable in April 2015

4. The Dearness Allowance so calculated shall be rounded off to the nearest rupee and Dearness Relief so calculated shall be rounded off to the next higher rupee.
