ORDER:

In terms of the orders issued vide G.O.1st cited, an Amendment to the Regulation.16(a)(1) of APSEB Service Regulations Part-I, as adopted by APGENCO, has been issued enhancing the age of superannuation from 58 years to 60 years "with immediate effect" vide G.O.O.4th cited. Further, an addendum to the said Regulation.16(a)(1) of APSEB Service Regulations Part-I has been issued vide G.O.O. 9th cited, substituting the words "with effect from 02.06.14" in place of "with immediate effect" in terms of the orders issued vide G.O.O. 8th cited read with G.O. 5th cited.

2. Further in the memo 10th cited, instructions have been issued to effect re-induction of retired employees in terms of aforesaid orders; wherein it is stipulated under para-5(a) & (b) that, he/she eligible for re-induction into service shall remit the pensionary benefits released to them, viz.(a) Commuted value of pension (b) Retirement Gratuity (c) Encashment of Earned Leave along with interest @ SBI MCLR+2.5% per annum till date of remittance, and "The re-induction shall be only against clear vacancy in the category. In the absence of a clear vacancy, before issuing re-induction orders, the Appointing Authority shall revert the junior most employees in the category".

3. Accordingly, in memo 11th cited, one Dy.CCA, two Senior Accounts Officers and one Accounts Officer who retired from service have been issued notices to remit the pensionary benefits released to them along with interest thereon on or before 30.09.2017. In response to the said notices, they have remitted the amounts and requested for issue of re-induction orders. There are no vacancies in the cadre of Dy.CCA, SAO and AO. To re-induct the retired personnel, the juniors in the seniority in the respective cadres shall require to be reverted.

4. After careful consideration, certain SAOs, AOs, AAOs mentioned in the Annexure enclosed to this order are hereby reverted to the lower cadres and posted to the places noted against each. However, upon reversion, their pay shall be re-fixed in the reverted cadre duly protecting the pay in the reverted cadre.

5. The concerned controlling officers are requested to relieve them with immediate effect so as to enable them to assume charge at the places of posting ordered above.
