The pay for the purpose of calculation of City Compensatory Allowance shall be the pay defined in FR 9(21)(a)(i).

3. After careful consideration and as per the Memorandum of statement, APGENCO hereby orders that CCA shall be allowed as per the rate in Government of A.P to the employees working in APGENCO.

4. The arrears of CCA from 02.06.2014 shall be paid in cash along with the salary for the month of May-2015 payable in the month of June-2015.
