WELFARE MEASURES – Group Janata Personal Accident policy for APGENCO employees- Renewal for further period of 3 years from 1.12.2017 to 30.11.2020 – Orders-Issued.

**ORDER :-**

In the G.O.O 1<sup>st</sup> read above sanction was accorded to M/s .Oriental Insurance Company Limited for coverage of Group Janata Personal Accident (GJPA) Policy for APGenco employees, for further renewal of three (3) years GJPA policy with a single premium of Rs.180/- (Rupees One Hundred and Eighty only) per employee for three years renewal period, which includes agency commission and directs that the GJPA policy for three years shall come into force from 1.12.2014 and continue till 30.11.2017 . This policy cover the APGENCO employees against the risk due to accident not only during the course of employment but also outside employment, such as road accidents, Burns due to fire, Drowning in water, death due to current shock, snake bite, dog bite, riots, actions of militants and murders and also total or partial permanent disability sustained in accidents.

- 2) The period of G.J.P.A policy mentioned in para one above will be expire by 30.11.2017.
- 3) The Senior Divisional Manager, M/s. Oriental Insurance Company Limited, Visakhapatnam vide letter read above, has come forward for renewal of the said Group Janata Personal Accident Policy (G.J.P.A.) for a further period of three years with a premium of Rs.166.50/- (Rupees One Hundred sixty six and fifty paise only) for employee, with the same terms and conditions as laid down in GOO 1<sup>st</sup> readabove.
- 4) The Policy offered by M/s Oriental Insurance Company Limited, Visakhapatnam covers the AP GENCO employees against risk on 24 hours basis whether the employees are on duty or otherwise covering accidental death/injuries due to electrocution, accidental falls, road accidents explosions, drowning in water, snake bite, dog bite, riots, actions of militants and murders.
- 5) After careful consideration, the APGENCO hereby considered and accepts the offer of M/s Oriental Insurance Company Limited, Divisional Office,-III #7-6-17/2 Kranthi arcade NH-5 road Chiitivaripalem Gajuvwaka Visakhapatnam for further renewal of three (3) years Group Jannata Personal Accident policy with a single premium of Rs.166.50/- (Rupees One Hundred and Sixtey six and fifty Paise) per employee for three years renewal period, Without agency services

and directs that the Group Jannata Personal Accident policy for three years shall come into force from 1.12.2017 and continue till 30.11.2020 and M/s Oriental Insurance Company Limited, Divisional Office,-III #7-6-17/2 Kranthi arcade NH-5 road Chiitivaripalem Gajuvwaka Visakhapatnam , shall cover the risk of employees of APGENCO from 1.12.2017 on the terms and conditions mentioned above. The present Group Jannata Personal Accident policy covers all monthly paid employees of the APGENCO. The amounts of insurance cover payable under the said policy are as follows:

i.	Death due to accident	-----Rs.1,00,000/-
ii.	Loss of use of two limbs/ Sight in both eyes due to Accidents.	-----Rs.1,00,000/-
iii.	Loss of use of one limb/Sight In one eye due to accident	-----Rs.50,000/-
iv.	Permanent total disablement due to accident	-----Rs.1,00,000/-

6) The Pay Officer, APGENCO, Vidyut Soudha, is requested to arrange the payment of Rs.9,95,170.50/- (Rupees Nine lakhs Ninety five thousand one hundred and fifty paiseonly) (i.e 5977 employees( Rs.166.50/- single Premium) to M/s Oriental Insurance Company Limited, Visakhapatnam towards Group Jannata Personal Accident policy for APGENCO employees for the renewed period of 3 years i.e from 1.12.2017 to 30.11.2020.

7) All the Pay Drawing Officers are requested to enforce this scheme as compulsory and recovery may be made from the salaries of the employees for the month of December 2017 payable on 1<sup>st</sup> January , 2018 and for accounting purpose book adjustment entry may be made without making any actual payment to the insurance company. A list of employees from whom the premium is recovered may be sent to the Pay Officer, APGENCO, Vidyut Soudha, Vijayawada and Senior Divisional Officer, M/s Oriental Insurance Company Limited, Divisional Office,-III #7-6-17/2 Kranthi arcade NH-5 road Chiitivaripalem Gajuvwaka Visakhapatnam .

8) The Senior Divisional Manager/Deputy Manager and Agent C.R.K Prasad, of M/s Oriental Insurance Company Ltd, Divisional Office,-III #7-6-17/2 Kranthi arcade NH-5 road Chiitivaripalem Gajuvwaka Visakhapatnam (Ph.No.0891 2516175, 2517156 ) will render Services during the above renewed policy period.
