ORDER :

In the G.O. 4<sup>th</sup> cited, the Government of Andhra Pradesh have issued orders duly increasing the limit on payment of House rent allowance to its employees with effect from 02.06.2014.

2. The Government of A.P., after due consideration of the recommendations of the PRC, orders have issued as follows:

(i) The existing classifications of cities, towns and the rates of allowances ordered in GO Ms.No.64, dated 09.03.2010 & GO Ms.No.59, dated 11.04.2011 of Finance (PC-I) Department, shall be retained for the purpose of admissibility of House Rent allowances as indicated below:

Classification of the cities & towns for payment of HRA

Hyderabad & Secunderabad classified as A-1 city and areas falling within the jurisdiction of Greater Hyderabad Municipal Corporation.	30% of Basic pay
Anantapuram, Eluru, Greater Visakhapatnam Municipal Corporation, Guntur, Kadapa, Kakinada, Kurnool, Nandyal, Nellore, Ongole, Proddatur, Rajahmundry, Tirupathi, Vijayawada, Vizianagaram.	20% of Basic pay

(ii) The above entitlement shall be subject to a ceiling of Rs. 20,000 per month for employee working and living in the Greater Hyderabad Municipal Corporation. For other places, the ceiling of HRA shall be Rs. 15,000.

3. After careful consideration and as per the Memorandum of statement, APGENCO hereby orders that HRA shall be allowed as per the rate in Government of A.P to the employees working in APGENCO.

4. The arrears of H.R.A. from 02.06.2014 shall be paid in cash along with the salary for the month of May-2015 payable in the month of June-2015.
