- 2) The words occurred at Clause (h) of Rule-2 under “definition” in the Allotment of Residential accommodation rules appended to the said G.O.O i.e., “**Penal Rent**” means **Twice the amount of Standard Rent** shall be read as “**Penal Rent**” means **10% of Gross Salary or HRA of the employee whichever is higher**”
