**ORDER:**

After careful consideration, approval is hereby accorded by the APGENCO to engage the following **THREE** Number Management Trainees ( CA/ICWAI ) on contract basis to work in the places against their names.

2. The following are the terms and conditions of their engaging on contract basis as Student Trainee.

- i) The engagement shall be for a period of **one year only** from the date of joining at the Place of posting.
- ii) The above selected candidates are required to execute a bond on Non-judicial stamp worth Rs.100 to that effect.
  - a) He/ She has to serve in APGENCO & in APTRANSCO for a minimum period of one year on contract basis.

- b) If the candidate request for resignation/termination within six months from the date of engagement, remuneration received shall be refunded in full. If the candidates request for the termination after six months, the refund of remuneration may be limited to three months.
- iii) The contract basis engagement shall be terminated with one-month notice on either side.
- iv) They shall be paid stipend amount of Rs. 20,000/- (Rupees Twenty Thousand only) per month. They are not eligible for any allowances.
- v) They shall produce original Certificates viz., Age (i.e., SSC), Educational certificates along with marks list, Caste Certificate issued by Revenue Officer not less than the rank of M.R.O./Tahsildar, latest by 6 months, Certificate of Residence/ School Study Certificates (from IVth to Xth class) and Experience certificates, duly submitting one set of Xerox copy of original certificates along with original Bond and Undertaking at the time of joining at the place of posting mentioned against them. After verification of certificates, the same shall be returned back.
- vi) They shall not exercise any monetary powers.
- vii) They shall submit an undertaking to the controlling officers as their engagement as Student Trainee is only on contract basis, and they shall not claim any rights for absorption in APGENCO at any time.
3. The stipend/salaries will be paid by APTRANSCO to the SI.No.2 & 3 candidates mentioned in the table of Para-1.


