ORDER:

After careful consideration, one vacant post of Assistant Accounts Officer from the control of Chief Engineer/O&M/Srisailam shall be diverted to Vidyuth Soudha/Hyderabad and re-designated as Liaison Officer in the scale of pay of Rs. 13905-575-15055-670-18405-770-21485 with effect from the date of actual utilization. The incumbent posted against the post of Liaison Officer is eligible to draw the usual allowances admissible to the post from time to time.

2. Under Regulation 14(a)(1) of A.P.S.E.B Service Regulations Part-II, as adopted, Sri T Kishan Singh, Junior Accounts Officer is appointed by transfer, purely on temporary basis, as Liaison Officer with effect from the date of assumption of charge.

3. Sri T Kishan Singh, Junior Accounts Officer on appointment by transfer as Liaison Officer as ordered above is transferred and posted against the post mentioned in para-1 above and he shall report to Director (Finance).

4. The appointment ordered above shall be subject to the following conditions:-

- (i) The appointment ordered above is purely temporary and does not confer any right to regular appointment as Liaison Officer.
- (ii) The temporary appointment ordered above is liable for termination at any time without notice and without assigning any reasons thereto.

5. The FA&CCA (Resources)/VS/Hyd is requested to relieve the above individual immediately by making local arrangements.
