ORDER:

Under Reg.14(a)(1) of APSEB SRs Part-II, as adopted, the following 2 (Two) Junior Personnel Officers of P&G Service are promoted temporarily to act as Personnel Officers with effect from the date of taking charge.

- ii) Smt.P. Pushpalatha

2. The promotions ordered in para-1 above are subject to the following conditions:-

- a) They are purely temporary and are liable for termination at any time without notice and without assigning any reasons thereto. The promotions ordered above are in relaxation of Regulation 14 of APSEB Service Regulations Part-III, as adopted, as they have not fulfilled the pre-requisite service condition mentioned in the Service Regulations due to exigency of work.
- b) They are subject to the result of SLP Nos.2360-91/83 filed by retired Officers of the A.P.S.E. Board and pending in Supreme Court.
- c) They should pass the APSEB Departmental Test for Administrative Officers Paper-II (without books) within one of the first two examinations after it is held, failing which the promotion ordered above are liable for termination without notice and without assigning any reasons thereto.

3. Sri B. Satyanarayana, Junior Personnel Officer, on temporary promotion as Personnel Officer, ordered in para -1 above, is transferred and posted as Personnel Officer / O&M/KIPS Vice Sri.M. Rajanarasimha, Personnel Officer, transferred.

4. On relief, Sri M. Rajanarasimha, Personnel Officer/O&M/KIPS is transferred and posted as Personnel Officer/O&M under the control of General Manager (HR) in the existing vacancy.

5. Smt.P. Pushpalatha, Junior Personnel Officer, on temporary promotion as Personnel Officer, ordered in para-1 above, is transferred and posted as Personnel Officer/O&M/RTS-B Station Vice Sri.N. Surendranath, Personnel Officer, transferred.

6. On relief, Sri. N. Surendranath, Personnel Officer/O&M/RIS 'B' Station is transferred and posted as Personnel Officer 'A' Section (Recruitment/Technical) under the control of Chief General Manager (Adm) against the post diverted in the reference 5th read above.

7. The concerned controlling officers are requested to relieve the above Junior Personnel Officers, on promotion as Personnel Officers, by making local arrangements within 15 days from the date of issue of this order. On expiry of 15 days he/she shall be deemed to have been relieved from the present place of working.

8. The two Junior Personnel Officers, on promotion as Personnel Officers are requested to assume charge on promotion as Personnel Officers at the place of posting. If they fail to join or evade joining within the stipulated period or proceed on leave from the date of receipt of this order, their promotion right shall be forfeited for the current panel and the names of the candidates shall be placed before the next DPC for consideration in the next panel year subject to availability of vacancy, in terms of orders issued in G.O.No:231/JS(P)/08 Dt:2.8.2008, over and above other departmental disciplinary action as deemed fit for non-compliance of orders. No request for change of posting or sanction of leave will be entertained.
