**ORDER:**

- 4) The **20 (Twenty)** Asst. Engineers/Telecom on temporary promotion as Assistant Divisional Engineers/Telecom are transferred and posted to the places noted against their names in the Annexure appended to this order.
- 5) The concerned controlling officers are requested to relieve the above Assistant Engineers/Telecom immediately by making local arrangements within 15 days from the date of issue of this order. On expiry of 15 days they shall be deemed to have been relieved from the present place of working.
- 6) They are requested to assume charge on promotion as Asst. Divisional Engineers/Telecom at the place of posting. If they fail to join, or evade joining within stipulated period, their promotion orders are liable to be cancelled without notice and forfeit all rights both present and future for such higher posts. No request for change of posting or sanction of leave will be entertained.
