- a) the Judgment to be delivered by the Hon'ble Supreme Court in the appeal filed against the judgment in W.P.No.4219/78 and W.P.Nos.2360-91/1983;
- b) the Judgment to be delivered in W.P.Nos.15565/89, 3482/90, 5135/90, 9558/91 and W.A.No.135/96 pending before the Hon'ble High Court of A.P;
- c) the Judgment to be delivered in W.P.No.3470/08 pending before the Hon'ble High Court of A.P.; and
- d) the clarification sought from the State Government in the letters 11th & 12th cited.

5. Sri Y. Kodanda Rama Rao, Divisional Engineer(Elecl.) working under the control of Chief Engineer/O&M/KTPS on promotion as Superintending Engineer(Elecl.) as ordered above is transferred and posted as Superintending Engineer/KTPS *vice* Sri V. Subba Rao, SE/Elecl. retiring from service on attaining the age of superannuation on 30.06.2008 AN.

Prabhakar Reddy, Divisional Engineer(Elecl.) working under the control of Chief Engineer/O&M/Srisailam on promotion as Superintending Engineer(Elecl.) as ordered above is transferred and posted as Superintending Engineer/Commercial/VS/Hyderabad *vice* Sri S. Siva Saranappa, SE/Elecl. retiring from service on attaining the age of superannuation on 30.06.2008 AN.

7. The concerned controlling officers are requested to relieve the above Divisional Engineers(Elecl.) by making local arrangements within 15 days from the date of issue of this order. On expiry of 15 days they shall be deemed to have been relieved from the present place of working.

8. The Divisional Engineers(Elecl.) are requested to assume charge on promotion as Superintending Engineers(Elecl.) at the place of posting. If, they fail to join or evade joining within stipulated period, their promotion orders are liable to be cancelled without notice and forfeit all rights both present and future for such higher post. No request for change of posting or sanction of leave will be entertained.
