4. The promotions ordered in Para-1 above are without prejudice to the position of officers that will emerge after review of FCG list of Senior Accountants and Accountants as on 01.11.1956.
5. The 5 (Five) Junior Accounts Officers on temporary promotion as Assistant Accounts Officers ordered in Para -1 above are transferred and posted to the places noted against their names in the Annexure appended to these orders.
6. The Concerned controlling officers are requested to relieve the above Junior Accounts Officers by making local arrangements within 15 days from the date of issue of this order.
