**ORDER:**

Under Regulation 14(a)(1) of APSEB-Service Regulations Part-II, as adopted, the following **2 (Two)** Assistant Divisional Engineers(Telecom) are promoted to act temporarily as Divisional Engineers(Telecom) with effect from the date of assumption of charge:-

- i) Sri P.V. Srinivas
- ii) Sri G.V. Dharma Rao

2. The promotions ordered in para-1 above are purely temporary and are liable to be terminated at any time without notice and without assigning any reasons. It is without prejudice to the seniority of the officers that will emerge after review of FCG list of Assistant Engineers as on 01-11-1956.

3. The promotions ordered in para-1 above are liable to be reviewed based on the outcome of ;-

- a) the Judgment to be delivered by the Hon'ble Supreme Court in the appeal filed against the judgment in W.P.Nos.2360-91/1983;
- b) the Judgment to be delivered in W.P.No.8509/88 and 10937/89 pending before the Hon'ble High Court of A.P;
- c) the Judgment to be delivered in W.P.No.3470/2008 pending before the Hon'ble High Court of A.P.; and
- d) the clarification sought from the State Government in the letter 2<sup>nd</sup> cited.

4. Sri P.V. Srinivas, Assistant Divisional Engineer(Telecom) on promotion as Divisional Engineer(Telecom) is transferred and posted as Divisional Engineer(Telecom) under the control of Executive Director(IS)/APGENCO/VS/Hyd. vice Sri V. Ramesh Babu, DE/Telecom retired from service on attaining the age of superannuation on 30.04.2008 PN.

5. Sri G.V. Dharma Rao, Assistant Divisional Engineer(Telecom) on promotion as Divisional Engineer(Telecom) is transferred and posted as Divisional Engineer(Telecom) under the control of Superintending Engineer/O&M/RTS-B in the existing vacancy.

6. The concerned controlling officers are requested to relieve the Assistant Divisional Engineers(Telecom) immediately by making local arrangements to enable them to join at the place of posting ordered above.

7. They are directed to assume charge on promotion as Divisional Engineer(Telecom) as ordered above after obtaining proper relief from the present place of working. If they fail to join or evade joining within stipulated period, their promotion orders are liable to be cancelled without notice and forfeit all rights both present and future for such higher post. No request for change of posting or sanction of leave will be entertained.
