2. After careful consideration, the following sanctions are accorded to DAV Public School, Puttamangandi.

- a) Rs.10,99,400/- (Rupees Ten lakhs ninety nine thousand four hundred only) towards estimated deficit fund as Financial Assistance for the year 2004 - 2005.
- X b) Rs.1,55,000/- (Rupees One lakh fifty five thousand only) towards capital expenditure to purchase books, equipment and furniture.
- c) Rs.1,20,000/- (Rupees One lakh twenty thousand only) towards Payment of Salaries of teachers and non teaching staff towards dues payable against last year.
- d) To provide Satellite phone facility in the school also to have communication access to teachers.

3. The above expenditure is chargeable to AMRP SLBC (Lift Scheme). As the Government of Andhra Pradesh is the owner of the Project specific permission to incur expenditure on DAV School at Puttamangandi may be obtained to avoid any future problems on this issue.


