ORDER :-

Under Regulation 14 (a) (1) of A.P.S.E.B. SRs Part -II, as adopted, 20 (Twenty) Junior Accounts Officers mentioned in the Annexure appended to this order are promoted temporarily to act as Assistant Accounts Officers with effect from the date of assumption of charge, after issue of these orders.

2. The promotions ordered in para -1 above are purely temporary and liable to be terminated at any time without notice and without assigning any reasons thereto.

4. The promotions ordered in para -1 above are also subject to result of S.L.P.Nos.2360-91/83 filed by Retired Officers of the erstwhile A.P.S.E.Board and pending in the Supreme Court.

5. The 20 (**Twenty**) Junior Accounts Officers on temporary promotion as Assistant Accounts Officers are transferred and posted to the places noted against their names in the Annexure appended to this order.

6. After careful consideration, the following orders are issued:
- a) Two vacant posts of Asst. Accounts Officers (1 AAO + 1 Jr. Audit Officer post re-designated as AAO) from the control of CE/O&M/RTPP are diverted to Vidyuth Soudha/Hyderabad and kept under the control of FA&CCA (Accounts) and Dy.CCA (Audit) one each.
 - b) One vacant post of Accounts Officer i.e. Cost Accountant re-designated as AO from the control of CE/O&M/KTPS-V shall be diverted to the control of FA&CCA (Accounts)/VS/Hyd.
 - c) One vacant post of Asst. Accounts Officer from the control of SE/MHSs/Pochampad shall be diverted to the control of FA&CCA (Resources)/VS/Hyd.

7. The concerned controlling officers are requested to relieve the Junior Accounts Officers immediately by making local arrangements pending posting of substitutes so as to enable them to assume charge as ordered above.

8. They are requested to assume charge accordingly after obtaining proper relief from the present place of working within 10 days from the date of relief. If they fail to join or evade to join within stipulated period, their promotion orders are liable to be cancelled without notice and forfeit all the rights both present and future for such higher posts. No request for change of posting or for sanction of leave will be entertained.
