ORDER

In the G.O.O. 1st cited, orders were issued revising the grades and eligibility to travel by the employees of APGENCO on tour, consequent on revision of Pay scales 2002.

2. In the G.O.O. 2nd cited, the APGENCO has issued orders adopting the Government rates of Travelling Allowance on tour admissible to the employees of APGENCO duly following the Grades ordered in G.O.O. 1st cited.

3. In the G.O.O. 3rd - 4th cited, scales of pay of the employees coming under workmen and other than workmen categories of APGENCO were revised with effect from 1.4.2006.

4. Consequent on revision of pays scales, 2006, the classification of grades are hereby revised as mentioned hereunder.

GRADES	Employees in the Revised Scale of Pay 2006
GRADE - I	Rs.18405-770-22255-860-26555-955-27510 and above
GRADE - II	Rs.11700-480-12180-575-15055-670-18405-770-19175 And above
GRADE - III	Rest of the employees

- (a) The employees of APGENCO drawing pay in the revised scales of pay of Rs.23975-860-26555-955-31330 and above may travel by Air-Conditioned First class for journey by train
- (b) The employees of APGENCO drawing pay of Rs.13905/- and above in the revised pay scales 2006 shall be eligible to travel by 1st class.
- (c) All other employees shall be eligible to travel by II Class

Note: " Officers eligible to travel by 1st Class may travel by A.C.Chair Car or AC-II Tier Sleeper while on official duty."

6. These orders shall come into force with immediate effect.

7. These orders are issued with the concurrence of Director(Finance) vide U.O.No.41,dated 10.04.2007.
