**ORDER:**

In the G.O.O 1st cited above, orders were issued for conversion of all the Mazdoors who are "Able to Read & Write" with below SSC, also those Mazdoors who possess SSC & above qualification and all these Mazdoors who have put in 5 years of service that counts for increment as on 31.12.2002 AN as Jr. Plant Attendants, subject to the terms and conditions mentioned therein.

2. Consequent to the Hon'ble High Court's orders, not to consider "One Time Benefit Concept" and instead directed to extend the benefit to all those Mazdoors who have completed 5 years of Service instead of linking to a cut off date of 31.12.2002, orders were issued vide reference 2nd cited for conducting Read & Write and Job Oriented Test every year in the month of July.

3. In pursuance of the directions of Honorable High Court and after careful consideration of the proposals submitted by the Station Heads in the references 3-11 cited, approval is hereby accorded for conversion of following Mazdoor posts held by eligible Mazdoors, who have completed 5 years of service and who satisfy the conditions laid down in G.O.O. 1st cited with the exemption of "One Time Benefit Concept" and cut off date of 31.12.2002, as Junior Plant Attendants posts as indicated below **FOR THE YEAR 2008.**

4. The incumbents counted against the above converted JPA posts shall be eligible to draw the usual scales of pay and allowances admissible at their place of duty.
