ORDER

The following Amendment is issued to the G.O.O.No.254/CGM(A)/2005, dated 28.09.2005.

AMENDMENT

Item (4) of the Annexure to the G.O.O.No.254/CGM(A)/ 2005, Dated 28.09.2005 shall be read as

"The orders issued in G.O.O.No.125/CGM(A)/2005, dt.30.6.2005 in respect of civil works, shall be extended to all works and additional security deposit shall be collected from the contractors. The Station heads shall incorporate the following in the tender schedules in all tenders."

"Tenders up to 25% less than the estimate may be accepted, but for tenders which are less by more than 25% of the estimate, Additional Security Deposit of 5% of the Estimated Value may be collected from the contractors. "

NOTE. However the concerned Station Head, Superintending Engineer, Divisional Engineer & Senior Accounts Officer, should satisfy themselves that the contractor who is quoting less by more than 25% of estimated value has the capability to carry out the works without compromising on quality. It is the personal responsibility of the concerned engineer to ensure quality in execution of the works"

2. Other guidelines stipulated in the G.O.O.No.254/CGM(A)/2005, dt.28.9.2005 shall remain unaltered/ unchanged.
