AP Genco – Medical – Homoeopathic Medical facilities at Vidyut Soudha –Honorarium of Homoeopathic Doctors for services rendered – Sanction – Accorded.

ORDER:-

In the reference 1st read above, sanction was accorded for payment of Rs.1,000/- each per month to Dr. M.Samba Murthy, BHMS(sm.) and Dr. Rajesh Deo, BHMS(Osm.) for service charges being rendered by them and also Rs.500/- per month for medicines to each Doctor.

2) Subsequently, AP TRANSCO has enhanced the honorarium of Homoeopathic Doctors from Rs.1,000/- to Rs.2,000/- per month keeping in view of the increase in cost of living and the amount for medicines was enhanced from Rs.500/- to Rs.600/- per month vide reference 2nd read above.

3) In their joint representation both the Doctors have represented that the staff of AP Genco are also attending to the clinic and as the cost of living index has also increased, they have requested to sanction an adequate allowance in addition to AP TRANSCO's sanction already accorded.

4) After careful consideration, the AP GENCO hereby accords sanction of honorarium to the above Homoeopathic Doctors of Rs.1,000/- pm.

5) The honorarium sanctioned above shall be in addition to Rs.2,000/- pm towards service charges and Rs.600/- pm for medicines to each doctor which are being paid by AP TRANSCO.

- 6) In view of the amount sanctioned above, Dr.M.S.Murthy, BHMS(Osm.) and Dr.Rajesh Deo, BHMS(Osm.) shall not collect either consultation fee or cost of the Medicine from the employees.
- 7) The Accounts Officer/CPR/AP Genco/Vidyut Soudha/Hyderabad is requested to arrange payment of the amount sanctioned in para 4 above as honorarium to Dr.M.S.Murthy, BHMS(Osm.) and Dr.Rajesh Deo, BHMS(Osm.).
