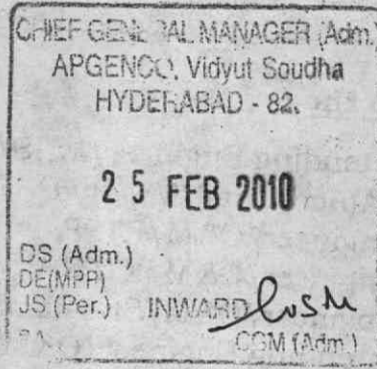

ORDER :-

3. The promotions ordered in Para-1 above are subject to result of S.L.P. Nos. 2360 – 91/83 filed by the Retired Officers of the erstwhile APSE Board and pending in the Honorable Supreme Court of India and W.P. No.4962/90 and 24969/95 pending in the Honorable High Court of Andhra Pradesh.
4. The promotions ordered in Para-1 above are without prejudice to the position of officers that will emerge after review of FCG list of Senior Accountants and Accountants as on 01.11.1956.
5. The 11 (Eleven) Junior Accounts Officers on temporary promotion as Assistant Accounts Officers ordered in Para -1 above are transferred and posted to the places noted against their names in the Annexure appended to these orders.
