It was also mentioned therein that the CGM (HR) shall fix the charges/fee to be collected from the information seekers from time to time.

In the reference 2<sup>nd</sup> read above, the Government of Andhra Pradesh in exercise of the powers conferred by Clauses (b) and (c) of sub-section (2) of Section 27 of the Right to Information Act, 2005 (Central Act 22 of 2005) has framed certain Rules called Andhra Pradesh Right to Information (Regulation of fee and cost) Rules, 2005, prescribing (i) application fee to accompany request for obtaining information; and (ii) fee to be charged for providing information in respect of (a) priced material and (b) other than priced material.

3. After careful consideration, the APGENCO hereby adopts the orders issued in G.O.Ms.No.454, General Administration (I&PR.II) Department, dtd. 13-10-2005 (copy enclosed).

All the Officers appointed as Public Information Officers/Assistant Public Information Officers at Corporate Office, Vidyut Soudha and Power Generating Stations of APGENCO under Section 5(1) of the Right to Information Act, 2005 (Central Act 22 of 2005) in the reference first read above are requested to follow the orders referred to in Para-3 above, scrupulously, without any deviation.


