**ORDER :**

Under Regulation 14(a)(1) of APSEB SRs Part-II, as adopted, **5 (Five)** Security Inspectors mentioned in the Annexure appended to this order are promoted temporarily as Assistant Security Officers with effect from the date of assumption of charge.

2. The promotions ordered in para-1 above are purely temporary and are liable to be terminated at any time without notice and without assigning any reasons.
3. The **5 (Five)** Security Inspectors on temporary promotion as Assistant Security Officers ordered in para-1 above are transferred and posted to the places noted against their names in the Annexure appended to this order.
4. The controlling officers are requested to relieve the individuals by making local arrangements to enable them to assume charge on promotion as Assistant Security Officers.
5. The Security Inspectors on promotion as Assistant Security Officers are directed to assume charge at the place of posting within 10 days from the date of relief. If they fail to join or evade joining within stipulated period, their promotion orders are liable to be cancelled without notice and forfeit all the rights both present and future for such higher posts. No request for change of posting or for sanction of leave will be entertained.
