ORDER:

Under Regulation 14 (a)(1) of APSEB SRs Part – II, as adopted, Sri.B.Rama Krishna Reddy, FM working under control of Chief Engineer/O&M/RTPP is appointed by transfer, purely on temporary basis, as Station Fire Officer.

The appointment ordered above is subject to the following conditions:

- a. The appointment ordered above is purely temporary and does not confer any right to regular appointment as Station Fire Officer.
- b. The temporary appointment ordered above is liable for termination at any time without notice and without assigning any reasons.
- c. The candidate shall submit Certificate of Physical Fitness issued by a Govt., Medical Officer of rank not lower than that of Civil Surgeon (or) District Medical Officer.
- d. The candidate selected for appointment by transfer as Station Fire Officer shall under-go the following training programs at National Industrial Security Academy, Hakeempet, Hyderabad after they join in their respective cadres at the place of posting ordered:
 - i) Fire Safety in Power Plant - From 23.04.07 to 28.04.07.
 - ii) Fire Officer Course - From 16.07.07 to 15.12.07.

Sri. B.Rama Krishna Reddy is eligible for TA and DA (1/4th of normal DA) during the training period.

- e. He should work in three shifts, if necessary.
- f. The seniority of the above candidate will be issued separately.
- g. He is eligible for usual allowance admissible to the post at the place of posting. They should produce original certificates of their educational qualification to the concerned controlling officers at the time of joining for verification.

3. Sri.B.Rama Krishna Reddy Fireman/RTPP on appointment by transfer as Station Fire Officer transferred and posted to the control of Chief Engineer/O&M/KTPS-V stage.
4. The Chief Engineer/O&M/RTPP is requested to relieve the above candidate immediately by making local arrangements in order to enable him to join at the place of posting ordered.
5. He is requested to join as Station Fire Officer at the place of posting within 10 days from the date of relief. If he fail to join, or evade to join within stipulated period, his appointment by transfer orders is liable to be cancelled without notice and forfeit all rights both present and future for such higher posts. No correspondence regarding posting will be entertained.
