**ORDER:**

Under Reg.14(a)(1) of APSEB Service Regulations Part-II, as adopted, **3 (Three)** Divisional Engineers(Elecl.) mentioned in the Annexure appended to this order are promoted to act temporarily as Superintending Engineers(Elecl.) with effect from the date of assumption of charge.

2. The promotions ordered above are purely temporary and liable to be terminated at any time without notice and without assigning any reasons thereto.
3. The promotions ordered above are subject to the result of W.Ps pending in the Supreme Court and also subject to revision if any consequent on review of promotions made to the category of Assistant Divisional Engineer/Elecl. after 01.11.1956 with reference to FCG list of JEs/Elecl. (Now AEs/Elecl.) and Supervisors/Elecl. Grade-I (now AAEs/Elecl.).
4. The promotions ordered above are liable to be reviewed in the light of judgment in W.P.No.4219/78 and subject to result of W.P.Nos:2360-91/83 filed by retired officers of the Board and pending in the Supreme Court and W.P.Nos.15565/89, 3482/90, 5135/90, 9558/91 and W.A.No.135/96 in the High Court of Andhra Pradesh.
5. The **3 (Three)** Divisional Engineers/Elecl. on temporary promotion as Superintending Engineers/Elecl. are transferred and posted to the places noted against their names in the Annexure appended to this order.
6. The concerned controlling officers are requested to relieve the above individuals, so as to enable them to assume charge on promotion as Superintending Engineers(Elecl.) as ordered above.

7. They are requested to assume charge accordingly after obtaining proper relief from the present place of working within 10 days from the date of relief. If they fail to join or evade to join within stipulated period, their promotion orders are liable to be cancelled without notice and forfeit all the rights both present and future for such higher posts.
