ORDER:

Under Regulation 14(a)(1) of APSEB-Service Regulations Part-II, as adopted, Sri K. Somasekhar Reddy, Divisional Engineer/Mechl. is promoted to act temporarily as Superintending Engineer/Mechl. with effect from the date of assumption of charge.

2. The promotion ordered in para-1 above is purely temporary and liable to be terminated at any time without notice and without assigning any reasons. It is without prejudice to the seniority of the officers that will emerge after review of FCG list of Assistant Engineers as on 01.11.1956.

3. The promotion ordered in para-1 above is liable to be reviewed based on the outcome of:-

- a) the Judgment to be delivered by the Hon'ble Supreme Court in the appeal filed against the judgment in W.P.Nos.2360-91/1983.
- b) the Judgment to be delivered in W.P.Nos.8509/88 and 10937/89 pending before the Hon'ble High Court of A.P.; and
- c) the Judgment to be delivered in W.P.No.3470/08 pending before the Hon'ble High Court of A.P.;

4. Sri K. Somasekhar Reddy, Divisional Engineer/Mechl. working under the control of Chief Engineer/O&M/RTPP on promotion as Superintending Engineer/Mechl. as ordered above is transferred and posted as Superintending Engineer/E&M/Construction-III/DSTPP under the control of Chief Engineer/Construction/DSTPP/VS/Hyd.

5. The Chief Engineer/O&M/RTPP is requested to relieve Sri K. Somasekhar Reddy, Divisional Engineer/Mechl. by making local arrangements within 15 days from the date of issue of this order, otherwise the promotee shall be treated as deemed to have been relieved of his duties after expiry of the stipulated period.
