In the reference read above, the Director, M/s. 3. The Accounts Officer (CPR) is requested to arrange for payment of an amount of Rs.39,611.00 (Rupees Thirty nine thousand six hundred and eleven only) to the M/s. Yashoda Hospital, Hyderabad against their credit bill under intimation to the Dy. Civil Surgeon, Vidyut Soudha Dispensary, Vidyut Soudha, Hyderabad.

4. An amount of Rs.38,941.00 is sanctioned to Sri N.Prasad Rao, OS, O/o SE/O&M/NSHES of Genco employee. A sum of Rs.670/- is recoverable from the employee. The SE/O&M/NSHES is requested to recover the amount accordingly from the first salary of the employee towards the cost of inadmissible items and intimate the same with C.B.Voucher No. _____ to the Deputy Civil Surgeon/VSD from the salary of the employee concerned, failing which disciplinary action will be initiated against the concerned pay drawing officer.

As of now, the APGenco has sanctioned an amount of Rs.38,941.00 (Rupees Thirty eight thousand nine hundred and forty one only) to Sri N.Prasad Rao, OS and the SE/O&M/NSHES is requested to arrange to enter the above amount in the Service Register of the individual and report compliance and this is the first sanction after issue of GOO 2nd cited.
