ORDER:

Under Regulation 14 (a)(1) of A.P.S.E. Board Service Regulations Part-II as adopted, the following 4 (four) Accounts Officers are promoted temporarily to act as Senior Accounts Officers with effect from the date of assumption of charge:

- ii. Sri G. V. V. Satyanarayana
- iii. Sri V. Vijaya Kumar
- iv. Sri C. V. Ramana Rao

2. The promotions ordered in Para-1 above are purely temporary and liable for termination at any time without notice and without assigning any reasons thereto.
3. The Promotions ordered above are in relaxation of Reg-14 of A.P.S.E. Board Service Regulations Part-III as adopted, as they have not fulfilled the prerequisite service condition mentioned in the Service Regulations due to exigency of work.
4. The promotions ordered in Para-1 above are subject to result of S.L.P.Nos.2360-91/83 filed by the Retired Officers of the erstwhile A.P.S.E. Board and pending in the Supreme Court of India and W.P.No.1173/91 pending in the High Court of Andhra Pradesh.
5. The promotions ordered in Para-1 above are also subject to result of W.P.No.17147/06 filed by the Accounts Officers of APGENCO and pending in the High Court of Andhra Pradesh.

6. After careful consideration, the following orders are issued:

- i. The post of SAO(Loans) existing under the control of FA&CCA(Res.) shall be diverted temporarily to the control of SE/E&M/KTPP/Chelpur.
- ii. Sri U. Naga Raju, AO on promotion as SAO ordered above is transferred & posted to the control of CE/O&M/KTPS vice Sri K. Bhaskar Rao, SAO transferred.
- iii. On relief, Sri K. Bhaskar Rao, SAO is transferred & posted as SAO/O&M/KTPS-V under the control of CE/O&M/KTPS-V in the existing vacancy.
- iv. Sri G. V. V. Satyanarayana, AO on promotion as SAO ordered above is transferred & posted as SAO under the control of CE/O&M/RTPP duly terminating the incharge arrangement ordered in Memo.No.JS(P)/DS(E)/AS(P)(N-T)/PO.K2/794/06, dtd.01.12.06.
- v. Sri V. Vijaya Kumar, AO on promotion as SAO ordered above is transferred & posted as Pay Officer vice Sri E. Rajaiah, SAO transferred.
- vi. On relief, Sri E. Rajaiah, SAO is transferred & posted as SAO/Power Bills vice Smt. E. Anuradha, SAO already transferred on promotion as Dy.CCA in the reference cited.
- vii. Sri C. V. Ramana Rao, AO on promotion as SAO ordered above is transferred & posted as SAO/KTPP against the post diverted in Para-6(i) above.
- viii. Consequently, Sri M. Venkateswara Rao, SAO(Loans) shall await posting orders.

7. The Concerned Controlling Officers are requested to relieve the above Accounts Officers immediately, by making local arrangements pending posting of substitutes in order to enable them to assume charge on promotion as Senior Accounts Officers at the place of posting ordered.

8. They are requested to assume charge accordingly after obtaining proper relief from the present place of working within 10 days from the date of relief. If they fail to join or evade to join within stipulated period, their promotion orders are liable to be cancelled without notice and forfeit all rights both present and future for such higher posts. They are informed that no request for change of postings or sanction of leave will be entertained.
