ORDER :-

In the reference first cited, orders were issued for appointing appellate Authorities, Public Information Officers and Assistant - Public Information Officers in respect of APGENCO under section 5(i) of the Right to Information Act, 2005.

In the reference second cited, certain instructions were issued to all the officers appointed/designated as Public Information Officer/ Assistant Public Information Officer at Corporate Officer as well as in the Power Generating Stations to take expeditious action for disposal of request for information.

3. In the reference third cited all the unit heads of Generating Stations (Thermal/Hydel) were requested to take suitable action on G.O.O.No.267/CGM(A)/05, Dt:04.10.05 to designate officers mentioned therein as Public Information Officer/Assistant Public Information Officer and furnish the information called for by the Government of Andhra Pradesh in the format indicated in para 4 of Memo Dt:22.06.2006.

4. Section 4 (1) (b) of the Right Information Act, 2005 indicates the obligations of public authorities on 17 points mentioned in the annexure enclosed herewith and the information on the above points must be placed in web.
