ORDER :-

Under Regulation-14(a)(1) of APSEB Service Regulations Part-II, as adopted, the following two **(02)** Security Inspectors are promoted to act temporarily as Assistant Security Officers with effect from the date of assumption of charge after issue of these orders.

- ii). Sri B.Satyanarayana

2). The promotions ordered in para-1 above are purely temporary and are liable to be terminated at any time without notice and without assigning any reasons thereto.

3). After careful consideration, the following orders are issued:

- i) Sri B.Satya Murthy, SI on promotion as Assistant Security Officer ordered above is transferred and posted as Assistant Security Officer/ Upper Sileru HES, duly terminating the incharge arrangement held by him.
- ii) Sri B.Satyanarayana, SI on promotion as Assistant Security Officer ordered above is transferred and posted as Assistant Security Officer/ RTPP, duly terminating the incharge arrangement held by him.

4). The concerned controlling officers are requested to relieve the above individuals by making local arrangements within 15 days from the date of issue of this order. Otherwise the promotees shall be treated as deemed to have been relieved of their duties after expiry of the stipulated period.

5). They are requested to assume charge on promotion at the place of posting. If they fail to join or evade joining within the stipulated period or proceeded on leave from the date of receipt of this order, their promotion right shall be forfeited for the current panel and the names of the candidates shall be placed before the next DPC for consideration in the next panel year subject to availability of vacancies, in terms of orders issued in G.O.O.No:231/JS(P)/08, Dt:2.8.2008. Necessary departmental disciplinary action as deemed fit shall also be initiated against them for non-compliance of orders issued above. No request for change of posting or sanction of leave will be entertained.
