**ORDER:**

Under Regulation 14 (a)(1) of APSEB SRs Part-II, as adopted, **3 (Three)** Junior Personnel Officers mentioned in the Annexure appended to this order are promoted temporarily to act as Personnel Officers with effect from the date of taking charge.

The promotions ordered in para-1 above are subject to the following conditions:-

- i) They are purely temporary and liable for termination at any time without notice and without assigning any reasons thereto. The promotions ordered above are in relaxation of Regulation 14 of APSEB SRs Part-III, as adopted, as they have not fulfilled the pre-requisite service condition mentioned in the Service Regulations due to exigency of work.
- ii) They are subject to the result of SLP.Nos.2360-91/83 filed by Retired Officers of the Board and pending in the Supreme Court.
- iii) They should pass the APSEB Departmental Test for Administrative Officers Part-II (without books) within one of the first two examinations after it is held failing which the promotions ordered above are liable for termination without notice and without assigning any reasons thereto.

The **3 (Three)** Junior Personnel Officers on their temporary promotion as Personnel Officers ordered above and **3 (Three)** existing Personnel Officers are transferred and posted to the places noted against their names in the Annexure appended to this order.

The concerned controlling officers are requested to relieve the Junior Personnel Officers immediately so as to enable them to join at the places of posting ordered above on promotion as Personnel Officers.

5) They are requested to assume charge on promotion as Personnel Officers as ordered above after obtaining proper relief from the present place of working. They are informed that no representation will be entertained for change of posting ordered. If they fail to join or evade to join within 10 days from the date of relief, they are liable to be reverted without notice and forfeit all rights both present and future for such higher posts.
