ORDER:

Under Reg.14(a)(1) of APSEB SRs Part-II, as adopted, the following 2 (Two) Accounts Officers are promoted temporarily to act as Senior Accounts Officers with effect from the date of assumption of charge.

- (ii) Sri K Bhaskar Rao

2. The promotions ordered in para-1 above are purely temporary and liable for termination at any time without notice and without assigning any reasons thereto. The promotions ordered above are in relaxation of Reg.14 of APSEB SRs Part-III, as adopted as they have not fulfilled the pre-requisite service condition mentioned in the Service Regulations due to exigency of work.

3. The promotions ordered in para-1 above are subject to result of S.L.P. Nos.2360-91/83 filed by the Retired Officers of the erstwhile A.P.S.E.Board and pending in the Supreme Court of India and W.P.No.1173/91 pending in the High Court of Andhra Pradesh.

4. The promotions ordered in para-1 above are also subject to result of W.P.No.17147/2006 filed by the Accounts Officers of APGENCO and pending in the High Court of Andhra Pradesh.

5. The following transfer and postings are ordered:

- (i) Sri V Srinivasa Rao, Accounts Officer on temporary promotion as Senior Accounts Officer ordered above is transferred and posted as Senior Accounts Officer/Stores/VS/Hyd under the control of FA&CCA (Accounts). The Costing Cell will be under the control of Sri V Srinivasa Rao, SAO.
- (iii) Sri K Bhaskar Rao, Accounts Officer on temporary promotion as Senior Accounts Officer ordered above is transferred and posted as Senior Accounts Officer/O&M/KTPS under the control of CE/O&M/KTPS vice Sri P Someswara Rao, SAO transferred. The Costing Cell at O&M/KTPS will be under the control of Sri K Bhaskar Rao, SAO.

- (iv) On relief, Sri P Someswara Rao, Senior Accounts Officer is transferred and posted as Senior Accounts Officer/VTPS under the control of CE/O&M/VTPS in the existing vacancy.

5. The controlling officers are requested to relieve the concerned Accounts Officers immediately, by making local arrangements pending posting of substitutes in order to enable them to assume charge on promotion as Senior Accounts Officers at the place of posting ordered.

6. They are requested to assume charge accordingly after obtaining proper relief from the present place of working within 10 days from the date of relief. If they fail to join or evade to join within stipulated period, their promotion orders are liable to be cancelled without notice and forfeit all rights both present and future for such higher posts. They are informed that no request for change of posting or sanction of leave will be entertained.
