7. The above Two Personnel Officers are requested to assume charge on promotion as Asst. Secretaries at the place of posting within 15 days from the date of receipt of this order. If they fail to join or evade joining within the stipulated period or proceed on leave from the date of receipt of this order, the promotion right shall be forfeited for the current panel and the names of the candidates shall be placed before the next DPC for consideration in the next panel year subject to availability of vacancy, in terms of orders issued in G.O.O.No:231/JS(P)/08 Dt:2.8.2008, over and above departmental action as deemed fit will be taken against them for non-compliance of orders. No request for change of posting or sanction of leave will be entertained.
