ORDER

The APGENCO is following the orders of the Government of A.P.for sanction of House Building Advance to the employees of APGENCO.

2. The Government of A.P. have issued orders enhancing the existing ceiling amount for sanction of House Building Advance to the State Government employees in the G.O. 3rd cited.

3. After careful consideration and in modification of the orders issued in the references 1st and 2nd cited, the APGENCO hereby enhance the existing ceiling of House Building Advance to the employees of APGENCO duly revising the pay ranges as per the Revised Pay Scales, 2006 vide references 4th & 5th cited.

Pay Ranges in Revised Pay Scales, 2006	Enhanced Maximum ceiling	Eligibility
a) Employees drawing basic pay up to Rs.10,665/-	Rs. 3.50 Lakhs	Or 72 times of basic pay which ever is less
b) Employees drawing pay above Rs.10,665/- and up to Rs.16,905/-	Rs.4.00 Lakhs	-- do --
c) Employees drawing basic pay above Rs.16,905/- and up to Rs.24,835/-	Rs.4.50 Lakhs	-- do --
d) Employees drawing basic pay above Rs.24,835/-	Rs.5.50 Lakhs	-- do --

4. The APGENCO further directs that the House Building Advance for repairs/enlargements shall continue to be at 15 times of basic pay subject to a maximum ceiling of Rs.90,000/- to those employees who have not availed HBA Loan and the revised recovery pattern shall be as follows:-

House Building Advance :: 300 Monthly Installments i.e.240 principle+ 60 interest.

Repairs :: 90 Monthly installments i.e. 75 principle + 15 interest

5. All other conditions governing the sanction of House Building Advance under the existing rules will continue.

6. The past cases in which orders were already issued granting the above advance shall not be reopened.

7. These orders shall come into force from the date of issue of the G.O.O.


