3. The promotions ordered in para -1 above are subject to result of S.L.P. Nos. 2360 -91/83 filed by the Retired Officers of the erstwhile APSE Board and pending in the Honourable Supreme Court of India and W.P. No.4962/90 and 24969/95 pending in the Honourable High Court of Andhra Pradesh.

4. The promotions ordered in para -1 above are without prejudice to the position of officers that will emerge after review of FCG list of Senior Accountants and Accountants as on 01.11.1956.

The 6 (Six) Assistant Accounts Officers on temporary promotion as Accounts Officers ordered in para -1 above are transferred and posted to the places noted against their names in the Annexure appended to this order.
