APGENCO - Regulations - P&G Service - JPOs/Sr.Stenos and Assts/Typists, who relinquished their right for promotion - Extension of Special Grade Post Scale to those who relinquished their promotion on completion of the period 3 years from the date of relinquishment of promotion - Orders - Issued.

ORDER:-

Regulation 40 of APSEB Service Regulation - Part II, as amended in B.P.Ms. No.365, dtd: 25.03.1996, inter-alia, stipulates that 'any person who relinquished his/her right for promotion earlier shall be considered for promotion at his/her request after three years from the date of such relinquishment. This second opportunity shall be final. The persons who relinquished their right for promotion shall not be eligible for appointment under Automatic Advancement Scheme i.e.,SGP/SPP Scales.

2. Certain employees belonging to P&G Service were permitted to relinquish their promotion to next higher post. Such of those who relinquished their right for promotion represented that they may be considered for appointment to S.G.P. scale under Automatic Advancement Scheme on completion of 8 years of service, as they have not got promotion.

3. After careful consideration, Andhra Pradesh Power Generation Corporation Limited, directs that:

“the JPOs/Senior Stenos, who had relinquished their promotions and in whose case no anomalies arise, if appointed to SGP scales and later promoted to the P.O. cadre, vis-a-vis the JPOs promoted directly to the P.O. cadre, be appointed to the SGP scales after conclusion of the period of three years from the date of relinquishment of their promotion.”

“the Typists/Assistants, who had relinquished their promotions and in whose case no anomalies arise, if appointed to SGP scales and later promoted to JPO cadre, vis-a-vis the Typists/Assistants promoted directly to JPO cadre, be appointed to the SGP scales after completion of the period of three years from the date of relinquishment of their promotions”.

4. The appointing authority shall obtain an undertaking from the employee to the effect that in the event of any anomaly in pay in future, the amount/s drawn by virtue of appointment of SGP Scale, shall be repaid in full.
