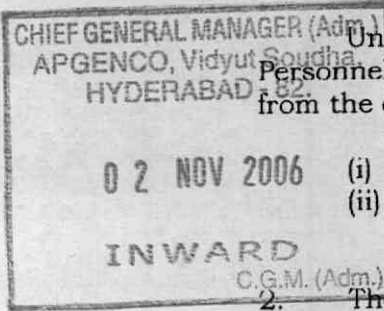

**ORDER:**



Under Reg.14 (a)(1) of APSEB SRs Part-II, as adopted, the following two Junior Personnel Officers are promoted temporarily to act as Personnel Officers with effect from the date of taking charge.

- (i) Smt B Manjula Rani
- (ii) Sri M Raja Narasimha

2. The Promotions ordered in para 1 above are subject to the following conditions:

- i. They are purely temporary and liable for termination at any time without notice and without assigning any reasons thereto. The promotions ordered above are in relaxation of Reg. 14 of A.P.S.E.B. S.Rs Part -III, as adopted, as they have not fulfilled the pre-requisite service condition mentioned in the Service Regulations due to exigency of work.
- ii. They are subject to the result of S.L.P. Nos.2360-91/83 filed by Retired Officers of the Board and pending in the Supreme Court.
- iii. They should pass the APSEB Departmental Test for Administrative Officers Paper-II (without books) within one of the first two examinations after it is held failing which the promotions ordered above are liable for termination without notice and without assigning any reasons thereto.

3. The above 2 (two) Junior Personnel Officers on promotion as Personnel Officers ordered above and 3 (Three) existing Personnel Officers are transferred and posted to the places noted against their names in the Annexure appended to this order.

4. Sri K Surbramanyam, Personnel Officer/GTPS is not entitled for TTA and joining time as the transfer is made at his own request.

5. The concerned controlling officers are requested to relieve the concerned Junior Personnel Officers/Personnel Officers on promotion/transfer immediately so as to enable them to join at the places of posting ordered.

6. They are requested to assume charge on promotion as Personnel Officers as ordered above after obtaining proper relief from the present place of working. They are informed that no representation will be entertained for change of posting ordered. If they fail to join, or evade to join within 10 days from the date of relief, the promotion orders are liable to be cancelled without notice and forfeit all rights both present and future for such higher posts.
