Under Regulation 14(a)(1) of APSEB SRs Part-II, as adopted by APGENCO, is

selected provisionally by the ANDHRA PRADESH POWER GENERATION CORPORATION LIMITED for appointment as Trainee Assistant Engineer(Telecom) in the time scale of pay of Rs.13905-575-15055-670-18405-770-21485 with usual allowances admissible from time to time and he/she shall be placed on training for a period of one year.

2) The selection of Trainee Assistant Engineer(Telecom) is provisional and liable for termination at any time without notice and without assigning any reasons.

3) The candidate will be governed by the rules and regulations applicable or as framed by the ANDHRA PRADESH POWER GENERATION CORPORATION LIMITED and as may be amended from time to time. The Tripartite Agreements entered into between the APSEB, Govt. of A.P. and Employees Associations are not applicable to these candidates and they shall at no stage be entitled to claim any right whatsoever arising out of the said Tripartite Agreements. He shall submit an undertaking in the Format-I enclosed herewith. Acceptance of his/her joining report is subject to the submission of the aforesaid undertaking.

4) The candidate appointed as Trainee Assistant Engineer(Telecom) shall be given posting orders on **26.10.2006**. The candidate shall undergo on job training at the place of posting ordered. He will be called for modular training to be conducted later.

5) He/she shall appear before the Chief General Manager(Adm.)/APGENCO, Room. No.250 'A' Block, Vidyut Soudha, Hyderabad and should submit the following documents in original for verification along with one more set of Xerox copies of such certificates at **10.00 AM** on **26.10.2006** and collect posting orders.

- i) *Certificates of Educational Qualifications viz., B.E/B.Tech./AMIE/M.E. /M.Tech. as reported in his/her application for appointment.*
- ii) *Documentary evidence of age viz., SSC/ICSE/CBSE or Date of Birth Certificate issued by the competent authority*
- iii) *Caste certificate issued by competent authority (latest by 6 months).*
- iv) *Joint Photograph with spouse, if married.*
- v) *Employment Exchange Registration Card, if any.*
- vi) *Certificate of Physical Fitness issued by a Govt. Medical Officer of rank not lower than that of Civil Surgeon (or) District Medical Officer.*
- vii) *The Attestation form enclosed in quadruplicate (4 sets) duly filled in by the candidate.*
- viii) *A bond on non-judicial stamp paper worth Rs.100/- (Rupees One hundred only) to the effect that he/she will serve the CORPORATION for a minimum period of 5 years in addition to training period, in case of appointment on regular basis.*

- ix) If the candidate leaves the CORPORATION during the period of training, he/ she shall refund to the Corporation the emoluments received by him/her during Training period plus Rs.30,000/- (Rupees Thirty thousand only) by way of liquidated damages.
- x) If the candidate leaves the CORPORATION during the bond period, he/she shall pay to the Corporation an amount of Rs.60,000/- (Rupees Sixty Thousand only) by way of liquidated damages.

Specimen forms of items vi, vii & viii are enclosed.

The original certificates will be retained until agreement period is over. He/she will not be admitted for training without submitting original certificates and the documents.

- 6) The appointment order is subject to the following conditions; namely:-
- (a) The appointment is subject to verification of character and antecedents. If any adverse report is received in the said verification, his/her services are liable for termination without notice.
- (b) The original certificates deposited with APGENCO shall be retained with the Corporation during six years bond period. However, the APGENCO shall consider for return of original certificates on temporary basis to the candidate after completion of three years from the date of joining, on return request after depositing caution money of Rs.30,000/- (Rupees Thirty Thousand only) with APGENCO which will be refunded on re-depositing back to the Corporation.
- (c) The candidate appointed as Trainee Assistant Engineer(Telecom) shall work wherever he/she is posted and no request for change of posting will be entertained.
- If he/she does not report on **26.10.2006** for verification of original certificates
- (d) the appointment order as Trainee Assistant Engineer(Telecom) shall be cancelled without further notice; and
- (e) No extension of time shall be granted to report for training.

7) The candidate will be governed by provisions of EPF & MP Act 1952 and the Employees Provident Funds Scheme 1952 in terms of GOO No.708/GM(Adm)/ 2002 Dtd. 6.2.2003.
