ORDER :-

In the references 1st to 3rd read above, APGENCO issued orders adopting the orders and instructions issued by GoAP from time to time on deferment of payment of salaries/ wages/ remunerations/ Honorarium/pensions in order to maintain financial balance due to Covid – 19 Pandemic.

2. In the Minutes of the Meeting dt.17.11.2020 held with APSPE JAC and YSR Vidyut Employee Union, it was agreed and mentioned in the minutes that **“The Deferred salaries for March and April 2020 will be released this year”**.

3. APGENCO, after careful examination and consideration, hereby ordered for release of the deferred payments of March 2020 and April 2020 Salaries/ Wages/ Remuneration/ Honorarium/ Pensions to all employees / outsourced workers/contract employees/ pensioners of APGENCO along with the regular Salaries/ Wages/ Remuneration/ Honorarium/ Pensions for the month of November 2020 payable in December 2020 and December 2020 payable in January 2021 respectively.

4. All the Pay Drawing & Disbursing Officers and other officers concerned are directed to recover all the Statutory deductions, Departmental recoveries, Bank/Society Loans, GPF Loan/Advance recovery etc., which were not deducted/not paid due to deferment of salaries for the periods mentioned above from the released deferred payments along with November 2020 salaries payable in December 2020 and December 2020 Payable in January 2021 respectively.

5. These orders are also applicable to the Employees/Pensioners who were allotted from TSGENCO to APGENCO vice-a-versa on bifurcation of the employees for whom salary/pension is deferred during March, 2020 and April 2020 due to COVID-19.

6. These orders are issued with the concurrence of Director/Finance vide e-office dated 01.12.2020.
