ORDER:

B.Lakshmipathi, AO and Sri.R.Anand Swaroop, AO were reviewed and promoted temporarily to act as Senior Accounts Officer duly reverting Sri.PSVRN.Bhushana Rao, SAO and Sri.A.Ramesh Babu, SAO as Accounts Officer and posted in the annexure appended to this order.

3. The promotion ordered in para -2 above is purely temporary and liable to be terminated at any time without notice and without assigning any reasons thereto.

5. The promotion ordered above is subject to review of final allocation of State cadre employees between APGENCO & TSGENCO, that may occur as per the AP Re-Organization Act, 2014.

6. They are requested to assume charge as ordered above, after obtaining proper relief from the present post. If fail to join or evade joining within the stipulated period or proceeded on leave from the date of receipt of this order, the promotion right shall be forfeited for the current panel year and the name of such candidate shall be placed before in the next panel year subject to availability of vacancies, in terms of orders issued in G.O.O. 
