ORDER :

In compliance of the directions contained in the concluding report dt.20.06.2020 read with supplementary report dt.11.03.2020 and final report dt 26.12.2019 of honourable One Man Committee, Sri.G.V.V. Satyanarayana, SAO(Emp.Id 1016903) had been finally allotted to APGENCO . Accordingly, he was posted as SAO (Costing & Power bills) under the control of FA&CCA(R&A)/APGENCO/VS/Vijayawada, he joined as such on 10.07.2020FN. As per the combined seniority list as on 02.06.2014 (i.e., appointed date of bifurcation of united A.P.), his seniority position was identified below to Sri K.Bhaskara Rao,& above Sri V.Vijaya Kumar(Retired) in the cadre of Sr. Accounts Officer. His immediate junior, Sri V.Vijaya Kumar, SAO(Retd.) was notionally promoted as Dy.Chief Controller of Accounts w.e.f 12.08.2016 in the approved list dt.10.08.2016 vide G.O.O. 2nd read above .

2. Under Regulation 14 (a) (1) of A.P.S.E.B. SRs Part –II read with Regulation 8(2)(a)&(c) of APSEB SRs Part - II, as adopted by APGENCO, the case of Sri.G.V.V. Satyanarayana,SAO was reviewed for promotion as Deputy Chief Controller of Accounts with effect from the date of assumption of charge of Sri V.Vijaya Kumar, SAO(Retd.) who was notionally promoted as Dy.Chief Controller of Accounts on 12.08.2016. However, the monitory benefit shall be paid from the date of actual assumption of charge as Dy.CCA on promotion.

3. The promotion ordered in para –2 above is purely temporary and liable to be terminated at any time without notice and without assigning any reasons thereto.

4. The promotion ordered in para –2 above is subject to the result of S.L.P.Nos.2360 –91/83 filed by the Retired Officers of the erstwhile APSE

Board and pending in the Honourable Supreme Court of India and W.P. No.1173/91 pending in the Honourable High Court of Andhra Pradesh.

5. The promotion ordered above is subject to review of final allocation of State cadre employees between APGENCO & TSGENCO, that may occur as per the AP Re-Organization Act, 2014.

6. Sri. G.V.V. Satyanarayana, Senior Accounts Officer O/o FA&CCA (R&A) on promotion as Deputy Chief Controller of Accounts ordered above is posted on deputation as Chief Financial Officer/APPDCL vice Sri.V.Venkateswarlu Dy.CCA is repatriated to APGENCO.

7. On relief and repatriation, Sri.V.Venkateswarulu, Dy.CCA/CFO is posted under the control of FA&CCA(A&T) against the post of Dy.CCA / O/oDirector(Finance&Commercial) duly reverting Sri.S.S.Ranganayakulu, Dy.CCA as Senior Accounts Officer.

8. On reversion, Sri.S.S.Ranganayakulu is transferred and posted as SAO under the control of CGM(Adm,IS&ERP) duly diverting the post of SAO from FA&CCA(R&A) and directed to look after the works of FICO module of ERP.

9. They are requested to assume charge as ordered above, after obtaining proper relief from the present post. If fail to join or evade joining within the stipulated period or proceeded on leave from the date of receipt of this order, the promotion right shall be forfeited for the current panel year and the name of such candidate shall be placed before in the next panel year subject to availability of vacancies, in terms of orders issued in G.O.O.No:231/JS(P)/08, Dated 02.08.2008. Necessary departmental disciplinary action as deemed fit shall also be initiated against him for non-compliance of the orders issued above. No request for change of posting or sanction of leave will be entertained.


